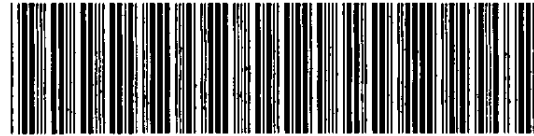

TO
ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of F. S. 607.1006, the undersigned Corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation as follows:

The undersigned, being the President and Secretary of Finstad Land & Spacial Surveying, Corp., a Florida corporation, hereby certify that the following Amendment to the Articles of Incorporation was duly adopted by the Voting Members and by the Board of Directors of the Corporation meetings duly held by them on the 10 day of JUNE, 2008. AMENDMENT
