ARTICLES OF INCORPORATION OF MEME AND PA'S LITTLE RASCALS PRESCHOOL & EARLY CHILDHOOD DEVELOPMENT CENTER, INC.

The undersigned Incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I.

Name

The name of this Corporation shall be MEME AND PA'S LITTLE RASCALS PRESCHOOL & EARLY CHILDHOOD DEVELOPMENT CENTER, TNC.

ARTICLE II.

Nature of Business

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida, but shall initially operate as a child care facility.
