## WATTABABE, INC.

THE UNDERSIGNED SUBSCRIBER to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

## **ARTICLE I - NAME**

The name of this corporation shall be: WATTABABE, INC.

#### **ARTICLE II - NATURE OF BUSINESS**

The nature of the business, and the objects or purposes to be transacted, promoted or carried on by the corporation as as follows:

- A. To carry on the business of creating, manufacturing, distributing and sale of clothing.
- B. E.
