

WE, the undersigned, all of whom are licensed to practice public accounting, hereby associate ourselves together for the purpose of forming a professional corporation under Chapters 621 and 607 under the laws of the State of Florida.

ARTICLE I  
NAME

The name of the corporation is THOMAS C. ROBERGE, P.A..

ARTICLE II  
DURATION

EFFECTIVE DATE

The term of existence of this Corporation shall commence on the 23rd day of November, 1998, and shall be perpetual.

ARTICLE III


The number of Directors may be either increased or decreased from time to time by the Bylaws but shall never be less than one (1).


