#### <u>ARTICLE I - NAME</u>

The name of this corporation is INVESTMENT TRUST COMPANY OF FLORIDA, INC.

## ARTICLE II - INITIAL PLACE OF BUSINESS, PRINCIPAL OFFICE AND MAILING ADDRESS

The street address of the initial place of business, principal office and the mailing address of the corporation shall be 2714 Rew Circle, Suite 200, Ocoee, Orange County, Florida 34761.

#### ARTICLE III - PURPOSE

The general nature of the business to be transacted by this corporation shall be that of a general trust company with all the rights, powers, and privileges granted and conferred by the Florida Financial Institutions Codes regulating the organization, powers, and management of trust corporations. The corporation may engage in any other activity or business permitted by law.

#### ARTICLE IV - CAPITAL STOCK

The corporation's authorized capital stock shall consist of 1,050,000 shares of \$1.00 per share par value common stock.
