The undersigned, for the purpose of forming a professional corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

### Article I Name

Section 1.1. Name. The name of this professional corporation is HASKELL ARCHITECTS AND ENGINEERS, P.A.

# Article II Duration

Section 2.1. <u>Duration</u>. This professional corporation shall exist perpetually. The effective date upon which this professional corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

# Article III Principal Office

Section 3.1. <u>Principal Office</u>. The address of the principal office of this professional corporation in the State of Florida is c/o 50 North Laura Street, Suite 3300, Jacksonville, Florida 32202.
