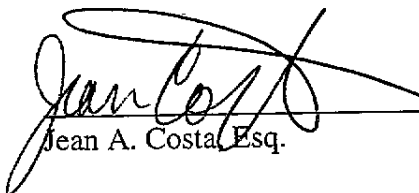

**ARTICLES OF INCORPORATION
FOR
FLORIDA STEEL DETAILING, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation is **FLORIDA STEEL DETAILING, INC.**

ARTICLE II

The existence of the corporation shall commence upon the filing of these articles of incorporation and its existence shall be perpetual.

ARTICLE III

The general nature and purpose of **FLORIDA STEEL DETAILING, INC.** is to provide detailing services to reinforcing steel suppliers for commercial and residential construction projects and to engage in the transaction of any lawful business for which corporations may be incorporate. This corporation shall be able to acquire, own, hold, manage and control real and personal property of every description, including stock in any corporation, and to sell and convey, mortgage, pledge, lease or otherwise dispose of such property or any part thereof, and to lend money either upon or without security.

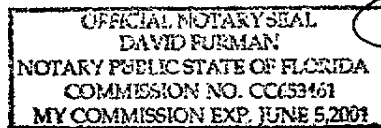
