The undersigned Subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is: A & E RESTAURANT CORPORATION.

ARTICLE II. NATURE AND POWERS OF BUSINESS

To engage in and conduct a restaurant business; and the doing and performing of any and all acts or things necessary, proper or convenient for or incidental to the furtherance or the carrying out of the powers or purposes herein mentioned.

To make and enter into all contracts necessary and proper for the conduct of the business or businesses of this corporation.
