The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I: NAME AND MAILING ADDRESS

The name of the corporation is C & B CONCRETE TECHNOLOGIES, INC., the address of the principal office of this corporation shall be 3170 SE Waaler Street, Stuart, Florida 34997 and the mailing address of the corporation shall P.O. Box 3016, Stuart, Florida 34995-3016.

ARTICLE II: NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory, or nation.

ARTICLE III: CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having no par value per share.
