## ARTICLES OF INCORPORATION SECRETARY OF STATE OF AB INTERIM BANK

The undersigned, acting as directors for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopt the following Articles of Incorporation.

### ARTICLE I

The name of the Corporation shall be AB Interim Bank and its initial place of business shall be 4400 PGA Boulevard, Suite 200 in the City of Palm Beach Gardens, in the County of Palm Beach, and the State of Florida.

### ARTICLE II

This corporation shall be organized as a successor institution in accordance with Section 658.40(4), Florida Statutes.

### ARTICLE III

The total number of shares authorized to be issued by the Corporation shall be 2,000,000. Such shares shall be of a single class and shall have a par value of \$1.00 per share. The Corporation shall begin business with at least \$1,000 in paid-in capital stock to be divided into 100 shares.

## ARTICLE IV

The term for which said corporation shall exist shall be one (1) year.

### ARTICLE V
