ARTICLES OF DISSOLUTION

Pursuant to Section 607.1403, Florida Statutes, A.R.K. & Son Investments G.P., Inc., a Florida corporation (the "Corporation"), submits the following Articles of Dissolution:

ARTICLE I

ARTICLE II

The voluntary dissolution of the Corporation is authorized as of October 31, 2015.

ARTICLE III

NOTICE OF DISSOLUTION OF A.R.K. & SON INVESTMENTS G.P., INC.
