

ARTICLE ONE: The name of the corporation is SUGARHILL RENTALS, INC..



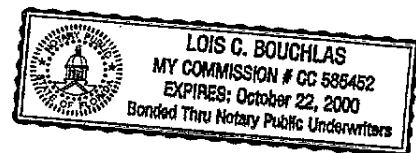
