**ARTICLES OF INCORPORATION**

**OF**

**CLOTHES-LINE CASUALS, INC.**

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of the corporation shall be CLOTHES-LINE CASUALS, INC.

**ARTICLE II - TERM**

The term of existence of the corporation shall be perpetual unless sooner dissolved as provided by law.

**ARTICLE III - PURPOSE**

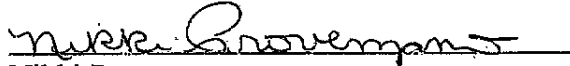
**ARTICLE VIII - EFFECTIVE DATE**

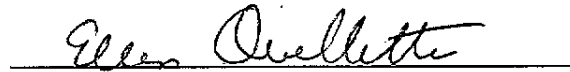
The corporation's existence shall be effective as of December 1, 1998.

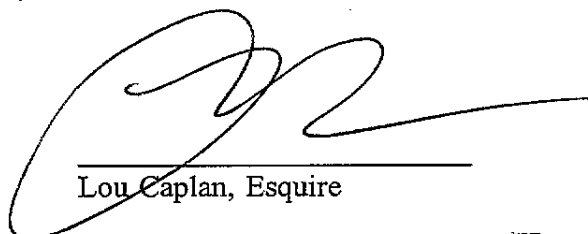
