## Articles of Incorporation for **DELLA ENTERPRISES, INC.**

#### Article I. CORPORATE NAME

SECRETARY OF STATE ARLLAHASSEE, FLORIDA

The name of this corporation is: DELLA ENTERPRISES, INC.

#### Article II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in the business of a hair and nail salon, along with any and all other business permitted under the laws of the United States of America and the great state of Florida.

#### Article III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock having par value of at least \$1.00 per share. Par value may be issued only for consideration having a value, in the judgment of the board of directors, at least equivalent to the full par value of the stock to be issued. No par shares may be issued only for such consideration as is determined by the board of directors. All shares issued shall be fully paid and nonassessable.

#### Article IV. TERMS OF EXISTENCE

The corporation shall have perpetual existence.

#### Article V. INITIAL REGISTERED AGENT AND INITIAL REGISTERED OFFICE
