ARTICLES OF INCORPORATION NOV 30 PM 3: 31

THE undersigned incorporator, being a natural person competent to contract for the
purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the
following Articles of Incorporation in order to form a corporation under the laws of the State of

ARTICLE I
