

ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of this Corporation is State of Florida Federation of Brazilian Jiu-Jitsu, Inc., and the address is 1809 East Colonial Drive, Suite 3, Orlando, Florida, 32803.

ARTICLE II. TERM OF EXISTENCE

This Corporation shall exist perpetually.

ARTICLE III. NATURE OF BUSINESS
