The undersigned *subscribers* to these Articles of Incorporation each a natural person competent to contract, hereby associate themselves together to form a corporation under the law of the State of Florida.

ARTICLE I. NAME

The name of this corporation is: ALL-IN-NET, INC.

ARTICLE II. NATURE OF THE BUSINESS.

The general nature of this business to be transacted by this corporation is any legal business in the State of Florida or in the United States.




ARTICLE IX. REGISTERED OFFICE AND REGISTERED AGENT


The registered office shall be at 4851 NW 79 Avenue Unit 4 Miami, Fl. 33166, and the registered agent being Joao Carvalho.

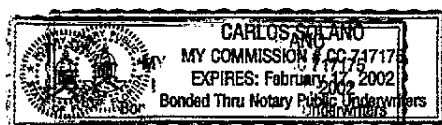
