### ARTICLES OF INCORPORATION

the undersigned subscriber to these Articles Incorporation, being a natural person competent to contract for the purpose of forming a corporation under the laws of the State of Florida, hereby adopt Articles of Incorporation as follows:

## ARTICLE I

The name of the corporation is BLACK CLEFF PRODUCTIONS, INC.

# ARTICLE II

The General nature of the business or business to be transacted by this corporation is

- (1) To purchase, lease, hire, or otherwise in any manner acquire, own, hold, operate, develop, manufacture, produce, process, improve, sell, assign, transfer, exchange, pledge or otherwise in any manner dispose of, turn to account or convey or deal in or with, as principal, agent broker, real property, improved or unimproved, and personal property, tangible or intangible, including, without limitation, securities and obligations of any issuer whether or not incorporated;
- To apply for, acquire, hold, own, enter into, use, dispose of and generally deal in and with grants, concessions, franchises, licenses, copyrights, patents, trade marks, trade names and similar rights and interest of every kind and description;
