

ARTICLE I  
NAME

The name of this corporation is INFORMATION DATA ANALYSIS, INC.

ARTICLE II  
DURATION

This corporation shall have perpetual existence commencing on November 30, 1998.

ARTICLE III  
PURPOSE


ARTICLE IX

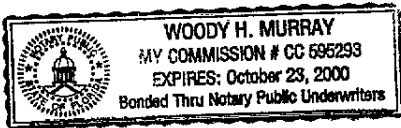


