The undersigned hereby states, for the purpose of forming a corporation under the laws of the State of Florida, providing for the formation, rights, privileges, immunities, and liabilities of corporation for profit, as follows:

### ARTICLE I - NAME

The name of this corporation, (hereinafter referred to as the "Corporation") shall be:

#### ARTICLE II - PURPOSE

This Corporation is organized for the purposes of:

- A. Establishment and management of residential relocation services and for executive customers and clients of the corporation and its affiliates, and further,
- B. Provide comprehensive consulting and advisory services to such corporate executive clients in all phases and in all aspects of residential relocation matters, and,
- c. Further, however, this Corporation is organized for the purpose of transacting any or all other lawful business activities.

# ARTICLE V - PRE-EMPTIVE RIGHTS

Every Shareholder, upon the sale for cash of any new stock of this Corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

# ARTICLE VI - INDEMNIFICATION

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.
