**ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

CORPORATE DURATION

The duration of the corporation is perpetual.

PURPOSE OR PURPOSES

CAPITALIZATION

The total number of shares of stock which the corporation is authorized to issue is ten thousand (10,000), all of which shall be Common Stock, and without par value. 
