

ARTICLES OF INCORPORATION

OF

The undersigned incorporator, a natural person competent to contract, hereby forms and establishes a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.



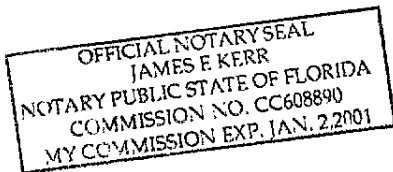
