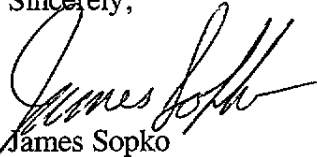

NAME

The name of this corporation shall be: I.P.P.B., INC.

ARTICLE II

TERM OF EXISTENCE
