I am an attorney who has at all times represented Mr. Alain LeClercq and his corporation 571 Oceanview Properties, Inc. Mr. LeClercq is a native French speaker with a limited command of the English language. I have at all times served as the Registered Agent for this corporation. When the corporation was formed my business address was Holland & Knight, 1499 S. Harbor City Boulevard, Suite 201, Melbourne, Florida 32901. In 2002, I changed firms and my new address became 1800 W. Hibiscus Boulevard, Suite 138, Melbourne, Florida 32901. In February of 2003, Mr. LeClercq prepared the annual corporate form noting thereon my change of address in the Registered Agent block. He forwarded this form to the Secretary of State's office. Unfortunately, no change was made to the principal place of business or mailing address reflected on the form. It appears that the Division of Corporations continued to send the annual report form to the old address. Therefore, I did not receive reporting forms for 2004 and 2005. Since no report was filed, the corporation was administratively dissolved. This matter has only recently come to my attention.

I am requesting that you accept this explanation for the delinquent filings and reinstate the corporation without imposing the reinstatement penalty.
