

ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is: FIRST CHOICE TITLE, INC.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

ARTICLE III: PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the United States and under the laws of the State of Florida.

ARTICLE IV: CAPITAL STOCK

The total number of shares of capital stock authorized to be issued by the Corporation will be one hundred (100) shares having a par value of one dollar (\$1.00) per share. Each of the said shares of stock will entitle the holder thereof to one (1) vote at any meeting of the stockholders.

ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT

The initial Registered Agent of the Corporation will be David R. Thompson, Jr. The initial street address of the Registered Agent and the principal office of the corporation in the State of Florida will be 1232 N. University Drive, Plantation, Florida 33322. The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

The registered agent herein states that he is familiar with and accepts the duties and responsibilities as registered agent for the corporation.

ARTICLE VI: INITIAL BOARD OF DIRECTORS

The Corporation will have two directors initially. The number of directors may be either increased or diminished from time to time by the by-laws. The name and street address of each person who is to serve as a member of the initial Board of Directors are:


ARTICLE VII: INCORPORATOR

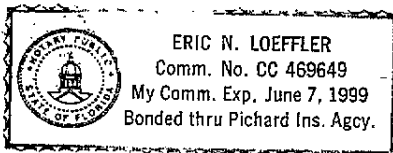


