ARTICLES OF INCORPORATION

OF

ACCURATE HOME INSPECTION COMPANY

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is Accurate Home Inspection Company.

ARTICLE TWO

The duration of the corporation is perpetual.
