#### ARTICLES OF INCORPORATION

#### FOR

## COBBLESTONE PROPERTIES OF NORTHEAST FLA., INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation

Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE ONE

The name of the corporation is COBBLESTONE PROPERTIES OF NORTHEAST FLA., INC.

#### ARTICLE TWO

The duration of the corporation is perpetual.

#### ARTICLE THREE

The general purposes for which the corporation is organized are:
