ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of the Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name and the principal place of business of this Corporation shall be:

ARTICLE II. DURATION

This Corporation is to exist perpetually.

ARTICLE III. NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States of America, the State of Florida or any other State, Country, Territory, or Nation.
