ARTICLES OF INCORPORATION
OF

I, THE UNDERSIGNED, In order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the Florida Business Corporation Code, do hereby certify as follows:

The Corporation is to have perpetual duration.


NINTH
