ARTICLE 1. - NAME AND ADDRESS

The name of this corporation is **KICKSPORT ENTERPRISES**, **INC.**, a Florida corporation, and the principal office and place of business is located at 8196 Woodland Center Boulevard, Tampa, Florida, 33614.

ARTICLE 2. - DURATION OF CORPORATION EXISTENCE

This corporation shall exist perpetually.

ARTICLE 3. - PURPOSES


