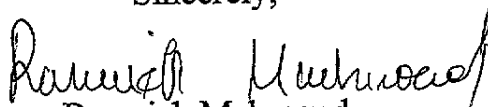

**ARTICLES OF INCORPORATION
OF
AMAN INC.**

The undersigned, acting as incorporator of a corporation under the Florida general corporation Act, adopts the following Articles of incorporation for such corporation:

1. The name of the corporation is AMAN INC.
2. The period of its duration is perpetual.
3. The purpose is to engage in any activities or business permitted under the law of the United States and in Florida, and to own and lease properties anywhere in the world.
4. The corporation shall have authority to issue one hundred (100) shares, all of one class of common voting stock, ten dollar (\$10.00) per value per share.
5. The amount of capital with which this corporation shall commence shall be not less than One Thousand Dollars (\$1,000.00).
6. The address of its initial registered office and of its principal office is 11800 SW 26 Court, Davie, Florida 33330, and the name of its initial registered agent at said address is RASMLAH MAHMOUD.
7. The number of directors constituting its initial board of directors is one (1) whose name and address as follows:

The preemptive rights shall be as follows: The holders of the common stock of this corporation shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the board of directors, such as the shares of the stock of this corporation as may be issued for money(money, or any property or services) from time to time, in addition to that stock authorized (and issued) by the corporation. The preemptive right of any holder is determined by ratio of the authorized (authorized and issued) shares of common stock held by the holder to all shares of common stock currently authorized (authorized and issued).

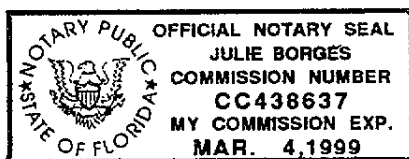
