ARTICLES OF INCORPORATION

ARTICLE I. CORPORATE NAME.

The name of this corporation is SHIV SHANTI, INC. and the principal place of business and mailing address of this corporation is 1025 Clearwater-Largo Road, Largo, Florida 33770.

ARTICLE II. DURATION.

This corporation shall exist perpetually.

ARTICLE III. PURPOSE.
