**ARTICLE I. CORPORATE NAME.**

The name of this corporation is **SHIV SHANTI, INC.** and the principal place of business and mailing address of this corporation is 1025 Clearwater-Largo Road, Largo, Florida 33770.

**ARTICLE II. DURATION.**

This corporation shall exist perpetually.

**ARTICLE III. PURPOSE.**




