Please be advised that this Corporation in which you are a shareholder, has elected to not pay the Florida Intangible Tax on behalf of the shareholders of this Corporation. The value per share of stock for the above Corporation as of the current year end is \$24.53 per share. This value per share should be used when preparing your personal Florida Intangible Tax Return.

The price per share was determined by the balance sheet attached to the corporate tax return.
