ARTICLE I.

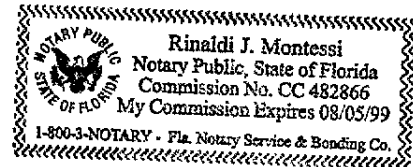
