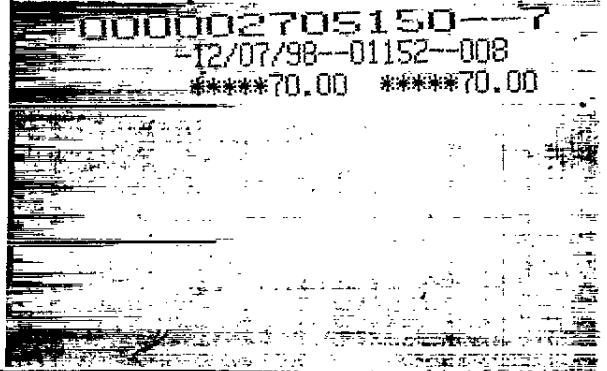

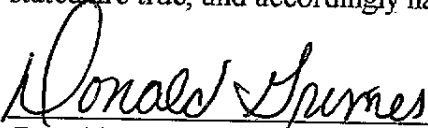
6. Existence.
