

ARTICLES OF INCORPORATION

OF

The undersigned, for the purposes of foregoing a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation.

ARTICLE I

Corporate Name and Address

The name of the corporation is Medical Billing Consultants, Inc. and the address is 8045 W. McNab Rd. Tamarac, Fl 33321.

Term of Existence



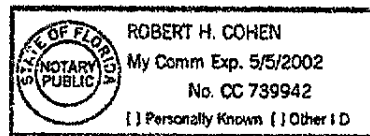
