The undersigned subscriber to these Articles of Incorporation, Being of legal age and a natural person, hereby forms a corporation for profit under the laws of the State of Florida.

## ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be Kayla Construction, Inc.

# ARTICLE II - GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

To engage in any activity or business permitted under the laws of the State of Florida

## <u> ARTICLE III - CAPITAL STOCK</u>

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share.
