PRINCIPAL OFFICE





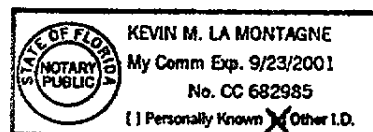
