**ARTICLE I. NAME; ADDRESS**

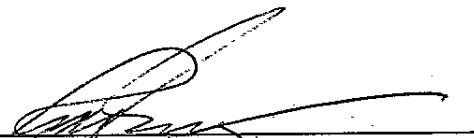
