In compliance with Chapter 607 of the Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purposes of organizing a business corporation.

ARTICLE I

NAME

The name of the corporation (the "Corporation") is:

MISSION TRANSPORTATION, INC.

ARTICLE II

PURPOSE

The purpose of the Corporation shall be to conduct any lawful activity.

ARTICLE III

PRINCIPAL ADDRESS

The address of the principal office of the Corporation is 5025 Collins Avenue, Miami Beach, Florida 33140.

ARTICLE IV

CAPITAL STOCK

The maximum number of shares which the Corporation is authorized to issue is 1,000, all of which shall be common stock, and which shall have a par value of \$.01 per share. All shares of the common stock shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon matters which shareholders have a right to vote.

ARTICLE V
