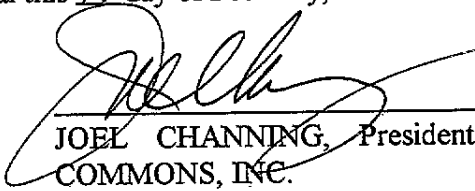
**ARTICLE I
