ARTICLE I

NAME

The name of this corporation is **MTN COMMUNICATIONS, INC.**, and the place of business shall be located at:

ARTICLE II

DURATION

This corporation's existence shall be effective and commence upon the filing of these Articles of Incorporation, and shall continue in perpetuity.

INDEMNIFICATION


The corporation shall have the authority to indemnify any officer, director or member, or any former officer, director or member, to the full extent permitted by law.



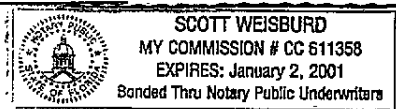


