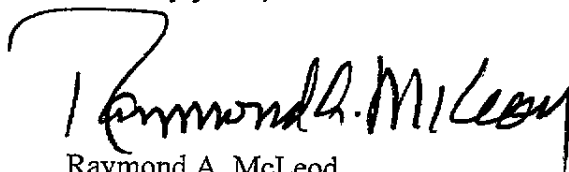

**ARTICLES OF INCORPORATION
OF

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of this corporation is **JCMA PARTNERS, INC.**

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose is to engage in any activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

The corporation is authorized to issue 1,000 shares, all of one class, at \$1.00 par value.

ARTICLE V

The name and address of the Initial Registered Agent is THOMAS H. SEILER whose mailing address is 900 Horizon Street, Deltona, Florida 32725 and the principal office of this corporation is 900 Horizon Street, Deltona, Florida 32725.

ARTICLE VI

This corporation shall have three (3) Directors initially, and the number of Directors may be either increased or decreased from time to time by an amendment of the By-Laws of the corporation in the manner provided by law, but shall never be less than one (1).

Director(s) need not be residents of this state or shareholders unless Articles of Incorporation or By-Laws so require.

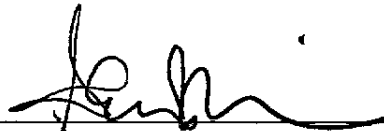
ARTICLE XI

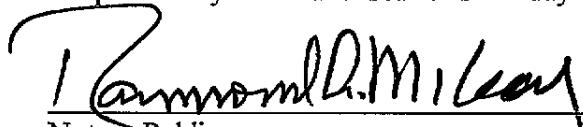
