1. **NAME:** The name of the Corporation is:

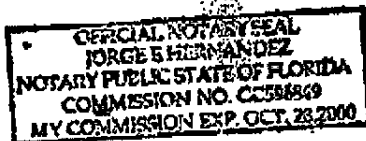


