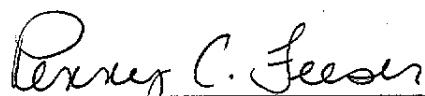
ARTICLE IX - COMMENCEMENT OF CORPORATE EXISTENCE
