The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1₈- NAME

The name of the Corporation is **PRIVATE ADJUSTER**, **INC.**, (hereinafter "Corporation").

ARTICLE 2 - PURPOSE OF CORPORATION
