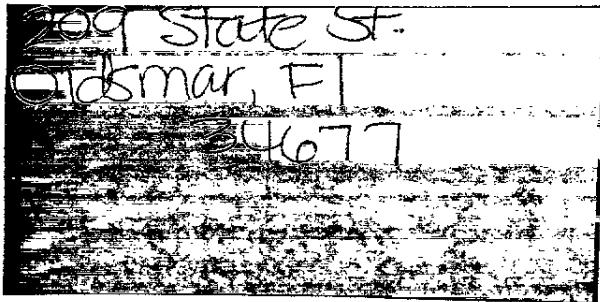

The undersigned Subscriber hereby makes, subscribes, acknowledges, and files with the Secretary of the State of Florida these Articles of Incorporation, for the purpose of forming a corporation for profit, in accordance with Chapter 607, Florida Statutes, Florida Business Corporation Act.

ARTICLE I - NAME

The name of this corporation is Rx TRIALS, INC., and the principal place of business and the mailing address of this corporation shall be 209 State Street, Oldsmar, Florida 34677.

ARTICLE II - NATURE OF THE BUSINESS

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLES III - REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial registered office of this corporation in the State of Florida is 209 State Street, Oldsmar, Florida 34677; and the initial registered agent is Morris Behar. The Board of Directors may, from time to time, move the location of the registered office to any other address in the State of Florida, and may, from time to time, change the registered agent of this corporation.

ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

This corporation will commence existence on December 1, 1998, and exist perpetually thereafter, unless dissolved according to law.

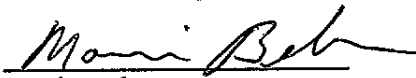
