NAME

The name of this corporation is MAKO CAPITAL , INC.

ARTICLE II

DURATION

This corporation shall have perpetual existence, commencing on the date of filing these Articles of Incorporation with the Florida Department of State.

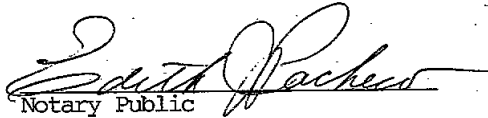

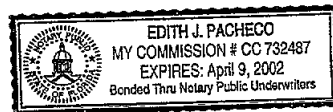

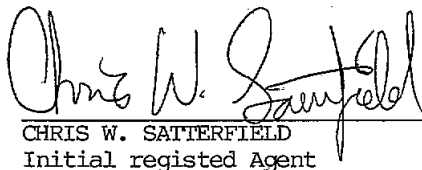
