#### ARTICLES OF INCORPORATION

By these Articles of Incorporation, the undersigned Subscriber forms a corporation in accordance with Chapter 607, <u>Florida Statutes</u>, and pursuant to the following provisions ("Articles"):

#### ARTICLE I

#### NAME

The name of the corporation shall be Florida Roof Systems & Analysis, Inc., and, for convenience, shall be referred to in this instrument as the "Corporation".

#### ARTICLE II

EFFECTIVE DATE

# EFFECTIVE DATE AND DURATION

The effective time and date of these Articles of Incorporation shall be 12:01 a.m., January 1, 1999, pursuant to Section 607.0123(2), Florida Statutes, at which time the corporate existence of the Corporation shall commence. The Corporation shall exist perpetually unless and until dissolved according to law.

#### ARTICLE III

# PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and mailing address of the Corporation is 1383 Cypress Avenue, Melbourne, Florida 32935.

#### ARTICLE IV

# REGISTERED OFFICE AND AGENT

Robert B. Harrison, whose address is 1383 Cypress Avenue, Melbourne, Florida 32935, is hereby appointed the initial registered agent of the Corporation and the registered office shall be at said address.

#### ARTICLE V

#### PURPOSES AND POWERS OF THE CORPORATION

The purposes of the Corporation shall be to engage in the business of providing consultation services and maintenance agreements for roof systems, and any and all other lawful purposes.

The Corporation shall have the power and duty to do any and all lawful things which may be authorized, assigned, required or permitted to be done by law, these Articles and the Bylaws, and to do and perform any and all acts which may be necessary or proper for, or incidental to, the exercise of any of the duties or powers of the Corporation. The duties and powers of the Corporation shall be exercised by the Board of Directors unless provided otherwise in these Articles of Incorporation or the Bylaws.

#### ARTICLE VI

# STOCK AND VOTING RIGHTS

The Corporation shall be authorized to issue 100 shares of common stock. Each outstanding share of stock shall entitle the owner thereof to one vote.

# ARTICLE VII

#### INDEMNIFICATION

The Corporation shall indemnify every officer, director, committee member and employee of the Corporation against any and all costs and expenses, including reasonable attorney's and paralegal's fees, reasonably incurred by or imposed upon such officer, director, committee member or employee in connection with any action, suit, or other proceeding, or appeal therefrom (including settlement of any suit or proceeding, if approved by the then Board of Directors) to which he may be a party by reason of being or having been an officer, director, committee member or employee of the Corporation. Such officers, directors, committee members and employees shall not be liable for any mistake of judgment, negligent or otherwise, except for their own individual willful misfeasance, malfeasance, misconduct, or bad faith. The officers and directors of the Corporation shall have no personal liability with respect to any contract or other commitment made by them, in good faith, on behalf of the Corporation (except to the extent that such contract or commitment may specifically provide otherwise), and the Corporation shall indemnify and forever hold each such officer and director free and harmless against any and all liability to others on account of any such contract or commitment. Any right to indemnification provided for herein shall not be exclusive of any other rights to which any officer, director, committee member, or employee, or former officer, director, committee member or employee may be entitled. The Corporation may, but shall not be obligated to, maintain adequate general liability and officers, and directors, liability insurance to fund this obligation, if such insurance is reasonably available.

#### ARTICLE VIII

#### BYLAWS

The initial Bylaws of the Corporation shall be adopted by the Board of Directors and may be altered, amended or rescinded in the manner provided by the Bylaws.

#### ARTICLE IX

#### AMENDMENTS

These Articles may be amended by the affirmative approval of a majority of the Board of Directors and the unanimous approval of all of the shareholders of the Corporation. However, the percentage of votes necessary to amend a specific clause shall not be less than the prescribed percentage of affirmative votes required, if at all, for action to be taken under that clause. No amendment shall be effective until filed with the office of the Florida Secretary of State.
